By agreeing to these terms and conditions, each applicant named in this application confirms their agreement of themselves and any adult member of the applicant's household to these terms and conditions.

Declaration of each Applicant.

I/we understand that if any person named in this application makes an application for accommodation in his/her own right, that person will, subject to verification checks, be removed from this application without further notice.

The information given on this form is, to the best of my knowledge, true and correct. I know I may lose any property offered to me if I have given false information or failed to supply any information requested. I undertake to promptly provide any updates and/or changes to household circumstances and undertake to ensure any necessary changes are made to this application.

Should any information in this application later be found to be incorrect or not appropriately updated, I accept that my application may be cancelled without further notice or may lose any particular priority/banding or time on the housing register.

I/We authorise any landlords detailed within this application to provide information about me or any member of my household to the Council , and for any enquiries necessary to support this application to be undertaken with them.

I/We authorise checks to be undertaken against my application details to identify any addresses or former tenancies to which I may have been party or resident and authorise any appropriate enquiries in relation to any such addresses or tenancies in order to allow full consideration of this application.

I/we understand that details of this application may be shared with other landlords participating in the Homes for Bolton scheme and may be shared for purposes of assessing my housing application with other external agencies, for example other Council Departments, the Police/Probation & other criminal-justice agencies, Department of Work And Pensions(DWP), landlords who may provide supported or temporary accommodation, or other agencies who may provide or have provided support the applicant and household members with a service.

I/we agree that any information sought in order to determine this housing application and/or consideration for any particular allocation will include all convictions and cautions related to me/us, any member of my/our household or any other associated person which are not limited to the restrictions detailed within the Rehabilitation of Offenders Act 1974.

I /we agree that details regarding any offences/convictions / cautions which may be categorised as spent under this Act may be sought, provided and shared as appropriate and relevant where there is justification to do so.
